 - Feedback shared on data presentation included:
 - Data showcased suicide is rising black youth
 - Ms. Stephanie Reid, Howard County Health Department, iterated that data can be bias and may not always paint the full picture and that it may only showcase problems affecting the most outspoken community members not the most impacted by disparity.

Further she detailed this report card is the evaluation of the health of Howard County residents across several key public health measures, including chronic disease risk factors, cancer incidence, leading causes of death, and maternal infant health and could help HMSPC pin down specific action items to address regarding mental health.	
Discussion in H gg s	essica Fisher invited the group to provide input on ncorporating safe storage and brain health focus into HMSPC efforts. Further she inquired how would HMSPC get community input on this topic and if a community survey would be the best way to get this input. • Ms. Barbara Allen, James Place/Opioid Collaborative Community Council, shared anecdotal stories about the issues with cannabis use among teens that she gathered from her community. • Ms. Jessica Lafave, Department of Veterans Affairs (Maryland), emphasized that safe storage does not only pertain to firearms but also to safe storage of medications. • Ms. Eileen Zeller, Moms Demand Action, iterated that surveying the community may not paint a full picture and that work can be done instead of waiting on community survey results. She also reiterated that safe storage incorporates all facets of a persons life and home, not just firearms, and should incorporate all lethal means.
