# **PROPOSED BY-LAWS CHANGES**

Key Changes:

- Enrollment changed from "open enrollment period" to rolling enrollment and removes reference to membership term limit of one year
- Calls for designation of voting member and proxy
- Proposes two-year term for Elected Delegates with option for renewal
