suicide prevention and mental health efforts to better address veteran suicidality and mental health in Howard County. He shared that the section of topic specific free resources located on the page was compiled from resources gathered by Ms. Jessica Lafave. The page also offers anyone access to Veterans resources that can apply to very specific situations or audiences (i.e., resources for tragedies, minority veterans, LGBTQ veterans, women veterans, older veterans).

Mr. Jordan referenced a brief from the Trevor Project, on Mental Health Among LGBTQ Youth with a Parent in the Military. Some information shared in the brief was that LGBTQ youth who reported having a parent currently in the military had significantly higher rates of mental health challenges and suicide risk or that LGBTQ youth with a parent currently in the military who reported high levels of family support had lower mental health challenges and suicide risk. He posed the question to the group on how the workgroup can better address the disparity faced by LGBTQ youth.

Dr. Chad Lennon and Ms. Kala Jenkins mentioned that first the workgroup would have to ensure that there are accessible safe spaces for these students and youth. Jessica Lafave reiterated the importance of ensuring safe spaces are available to youth. She also emphasized that before we can be so specific with our approach it may be conducive for us to start at addressing the stigma associated with LGBTQ community among the youth and the military.

Ms. Lisa Terry seconded that addressing the stigma associated with LGBTQ community among active-duty military and veterans may help us better serve LGBTQ military-connected youth.

Dr. Lennon inquired if LGBTQ resources were available on the Howard County Public School System (HCPSS) website as well as through the Veterans resource page on the LHIC website. Mr. Ashton Jordan provided the link to the LGBTQ veteran resources and Ms. Laura Torres provided the link to the HCPSS LGBTQ resources.

Jessica Lafave and Dr. Lennon mentioned reducing the amount of silos HC residents may get in to searching for

	resources. He suggested having all LGBTQ related veteran/military-connected youth resources in a central location for all to access. Ms. Natalie Hall gave a brief overview on CAREAPP, a free resource to connect residents to resources related to services and Social Determinants of Health. Ms. Hall mentioned that there are two versions for CAREAPP. There is a provider/partner version and resident/seeker of program version. She mentioned that the resident/seeker version will land the resident first on a page that requires them to input their zip-code, then programs and resources available in their zip-code will appear. Residents have access to different categories of care programs and resources they can choose from (food, housing, goods, transit, health, money, care, education, work, and legal). The provider/partner version allows partners with a CAREAPP login to view the referrals made to their program as well as information of the people they are helping.
