- The Office on Aging and independence is offering a new class, Stepping Up for Nutrition. This new program includes nutritional assessment and counseling and fall risk identification. This program all serves as a referral point for falls prevention or CDSM evidence-based programs. The class will be offered at the Elkridge 50+ Center. Anne Brinker with the Community Action Council shared that Head Start is currently enrolling students for the full-day, full-year program. Standard eligibility is 100% of the Federal Poverty Level or a vulnerable population. For the Pre-K program it is 200% of the Federal Poverty Level. Immediate preference is given to any homeless children that need to be enrolled in an education program. Sign-up for the program can be done within the main office at 6751 Columbia Gateway Drive, or the four individual Head Start locations.
