Suicide prevention is a key priority area of the Local Health Improvement Coalition (LHIC) Strategic Plan and HCHD Strategic Plan. As such, the Howard County Suicide Prevention Coalition will function as Behavioral Health Workgroup under LHIC.

Coalition aims to tackle action items across behavioral health continuum to address upstream prevention, access to care and referral processes, interventions, and postvention resources.

Reena plans to hold an LHIC speaker event with researcher who will present on suicide trends among vulnerable populations, including LGBTQIA+ individuals and veterans in April. Leah/HCHD Suicide Prevention Coordinator to provide coordination support. Event will serve as a "launch" for the Suicide Prevention Campaign.

i. What would you like to achieve this year?

ii. How will we measure success?

Six action items/priority areas were identified including, 1. Veteran outreach; 2. Older adult outreach; 3. Youth/adolescent outreach and education; 4. Parent education/support; 5. Behavioral integration into primary care/screenings; 6. Reducing access to lethal means

- 1. Veterans resources and support there are 17,000 veterans in Howard County.
 - Jess from VA in Baltimore is offering support in outreach to veteran community

 she's able to present on local VA data and veteran issues and provide
 resources/toolkits
 - o A presentation from Jess could be added to LHIC meeting with speaker in April
- 2. Outreach to older adults, promote understanding that older adults are a population at risk
 - Older adults are often coping with unmet expectations in life, chronic illnesses, major life transitions
 - o Support and education for caregivers on mental health and older adults
 - Connect with Renee AERS (Adult Evaluation and Review Services) about suicide prevention efforts – could provide feedback on older adult and adult with disabilities populations.
 - Medicare Annual Wellness Visit as opportunity for engagement (see BH integration in PCP below)
- 3. Outreach to youth and adolescents
 - Outreach specifically about how to identify accurate information on social media regarding mental health and how to discern misinformation/inaccurate information
 - Reach out to teens with accurate information in a relatable format
 - Include youth in suicide prevention campaigning efforts Tiffany suggests contests to engage youth in process
 - Refresh youth messaging prior campaign was released 3 years ago and messages/images need updating
 - Middle school youth outreach
- 4. Education and support for parents around what is normal behavior vs what signifies time to reach out for help
 - If a child makes a statement about wanting to hurt themselves, wishing they
 were no longer alive, etc, education on how to know when to get help, how to talk
 to the child about those statements without dissuading them from reaching out for
 help in the future
 - Could hold a parenting series/workshop on determining difference between what's normal for child development and when to seek professional help
 - Local Children's Board has one in the works around how to access therapy and mental health treatment – perhaps could expand into workshop series and publicize to each of our groups
 - Reviewing self-harm indicators and raising awareness among community members and providers
- 5. Expanding behavioral health integration into primary care settings

- This is a major goal of the Bureau of Behavioral Health and HCHD
- Could renew BHIPP (Behavioral Health Integration in Pediatric Primary Care)
 outreach to pediatric providers in Howard County
- Promoting screening and referral among primary care physicians
 - Medicare Annual Wellness Visits could provide opportunity for targeted outreach to physicians treating older adults
 - Could create guide for physicians with action steps and resources to refer to if a patient identifies behavioral health concerns
- 6. Reduce access to lethal means in Howard County
 - HCPD looking to connect with resources to provide free gun locks to community members
 - Alex (Office of Suicide Prevention at BHA) and Jess (VA) both have access to supplies of gun locks that could be distributed to the police department
 - Increase safe storage access and gun shop outreach there are no voluntary gun storage locations in Howard County: https://mdpgv.org/safestoragemap/ (closest is Mt. Airy)
 - Reach out to community members with materials about the benefits of safe storage for families with children
 - Promote awareness around safe storage of over the counter medications like
 Tylenol, in addition to prescription narcotics, and other commonly held household
 items that could become lethal means
 - Jess had handouts and resources regarding lethal means

III. Action Item #1: Suicide Prevention Campaign

- a. Review images and sample messaging
- b. Provide feedback on images, messages, and resources

Initial feedback on Suicide Prevention Campaign images included:

- Healthcare worker representation
- Different branches of military, more diversity in service members/veterans (older adult veterans, women)
- Include peer-staffed crisis services for veterans
- More diversity among Latinx population in images
